## Wage Tax Stamps of the Netherlands Indies and Indonesia

#### by Terence Hines, ARA

The revenue stamps of the Netherlands Indies and Indonesia present a real challenge to any collector. The stamps, in one form or another, have been in use since 1818 (Van der Poel, 1954). Numerous different,

often exotic, commodities, have been subject to taxes for which revenue stamps have been issued. Combine this with the difficulties of distance and language and it can be quite difficult to discover the details behind the issuance of any particular type of stamp, let alone

> the basic information on the specific stamps issued. This article concerns the stamps issued to pay a tax on wages apparently first imposed in 1938. The recent acquisition of several full documents bearing these stamps has shed considerable light on their use and makes this article possible. Previous, and less complete, listing of these stamps have appeared previously in Vand der Poel (1954), Hines (1973) and Barefoot (1987).


The first series of wage tax stamps (*loonzegel* in Dutch) for use in the Netherlands Indies appeared in 1938. The series was made up of at least 18 double stamps, ranging in face value from 5 sen to 100 Gldn. A full listing appears at the end of this article for this and other series. The left stamp is inscribed *loonzegel* and was affixed to the appropriate document. The right half is inscribed *loonzegel / controle* and was presumably kept by the issuing authority. An example of this series appears in Figure 1. Figure 2 shows the type of document to which these stamps were

*Figure 4.* A document bearing the occupation stamps of the type in Figure 3.


affixed. It bears five stamps in four different denominations. The form is divided into four columns. The far left column is used to record the amount of taxable wages. The second column is for any additional taxable wages. The third column repeats the total amount of taxable wages in words. The far right column is for the stamps, where they are affixed, dated and canceled. While the document makes no mention of the tax rate, from the face value of the stamps and the amount of taxable wages on each line, it appears as if the tax rate was 4%, at least for amounts of 125 Gldn. or less.

One interesting aspect of this document is that it was used during the Japanese occupation of the Netherlands Indies. The document is printed in Indonesian and Japanese and is dated in the year "2603," the Japanese style of dating the year. In spite of the fact that this document was used under Japanese occupation, the old Netherlands Indies stamps were still in use. This would not last for long.

The Japanese did issue a set of occupa-

tion wage tax stamps. These, like their Dutch predecessors, were double stamps. An example is shown in Figure 3. The inscriptions are in Indonesian and Japanese, in line with the Japanese policy of currying the favor of the Indonesian population by removing references to, and the language of, the previous Dutch "oppressors." On the illustrated stamp, *Meterai Oepah* translates as stamp (for) wages."

Figure 4 shows a document with four Japanese occupation meterai oepah stamps used. Also used is one of the older Netherlands Indies issues. Thus, the



document shows an interesting mixed usage. Once again, a comparison of the face values of the stamps on each line with the amount of taxable wages shows that the tax rate was 4%.


At the end of the war, and the end of Japanese occupation, the political situation in Indonesia became extremely confused. Some areas were controlled by the Dutch and others by Indonesian rebels. Both issued postage, as well as revenue stamps. The interested reader can consult any standard history of Indonesia for details of this difficult period in the

country's history. As far as the present article is concerned, the political trouble resulted in the issuance of wage tax stamps both by the returning Dutch authorities and by the revolutionary Indonesian government.

Apparently in 1945 the Indonesian revolutionary government issued a set of at least 14 imperforate



double stamps (example in Figure 5). The examples I have seen are ungummed and I have never seen either a used copy or a copy affixed to a document. This does not, of course, prove that these stamps never saw actual use, but it does suggest it as a possibility. As on the Japanese occupation double stamps, the right stamp is inscribed *pengawasan* which is Indonesian for control."

Van der Poel (1954) reports a single, crudely printed, Japanese occupation *Segel Oepah* (Wage tax stamp) with a 10 Gldn. denomination, printed in black on white paper, imperforate. This is a double stamp with the rising sun at top.

I have seen one, previously unreported, wage tax stamp that seems to date from the revolutionary period or, perhaps, from the period (1949-1951) just following the establishment of the Indonesian Republic as a legitimate independent state. This is a copy of the 2 Gldn. value from the 1938 Netherlands Indies series, the right, or *controle* half only, overprinted as

follows, in black. At the top of the stamp the overprint reads "Meterai Oepah / PENGAWASAN" while at the bottom it reads "REPOUBLIK/INDONESIA."; there is a line through the "TWEE GULDEN" denomination.

While the Indonesian revolutionaries were busy issuing their own wage tax stamps, the Dutch did not fail to issue their own. An example of the new design, which is not a double stamp, is shown in Figure 6. Note that the name of the country is now "INDONESIA," presumably as an attempt to pacify local anti-Dutch feelings. One may speculate that eliminating the tax would have gone further in that direction. In any event, Figure 7 shows a document

from 1949 with six copies of the 2.50 Gldn. value used. The reverse of this document indicates that, for the first time as far as I know, the tax rate was graduated. Amounts of less than 300 Gldn. were subject to a 5%

tax. Amounts of 390 to 666.65 Gldn. were subject to a tax of 10% while amounts of 666.66 Gldn. or higher were subject to a 15% tax.

There are two distinct types of the Indonesia *loonzegel* stamps. As the listing at the end of this article shows, most values have a red underprint. But a few are known with a yellow underprint. The reason for the change from red to yellow (or vice versa) is unknown. Hines (1973) speculated that it might have taken place upon Indonesian independence, but no evidence to support this has appeared.

With the full emergence of a legitimate Indonesian Republic, new wage tax stamps appeared. Political control may change, but the real oppressors, taxes, seem never to go away. The new, truly Indonesian, stamps were inscribed "METERAI / UPAH" for "stamp (for) wages." By the time this series was released, the official change in the orthography which changed the old Dutch "oe" to the Indonesian "u" had been made.


These stamps come in several varieties. There are two perforation varieties,  $12.5 \times 12.5$  and 12.5 and 12. Within each perforation type, two additional varieties exist which can best be distinguished by the type face of the word *tanggal* (date). One variety has *tanggal* in italics while the other has it in non-italic type.

Figure 8 shows the two types.

Figure 9 shows a 1962 document with numerous meterai upah stamps affixed. The unillustrated side of the document spells out the tax rates. For amounts of Rp. 500 or less, the rate was 3%. Between Rp. 500 and 1,000 the rate was 5%. Between Rp. 1,000 and 1,500 it was 7% and from 1,500 to Rp. 2,500 it was 10%. For amounts above 2,500 the tax rate was 15%.

I have seen no meterai upah stamps or documents after the early 1960s. Thus, it appears as if this specific tax was phased out about that time. An income tax may still exist in Indonesia, but it is, apparently, not paid with the use of stamps.

The Combs Catalog of Usages and Varieties of U.S. Embossed Revenue Stamped Paper 1791-1817, by W. V. Combs. 100 +viii pages, 8.5 x 11 inches, hard cover smyth sewn, unpriced (scarcity index), unillustrated. Published by the author. Available from Golden Philatelics, Leonard Hartman or Eric Jackson for \$27.50; may also be available from other dealers now.

Leonard Hartman describes this as "a priced catalog without prices, an excellent idea." This catalog takes the user through each of the three issues of U.S. federal embossed revenue stamps, arranges them by usage and prices them with a multiplier value. This value is then applied to the current standard catalog value for that stamp to determine the value of a

### The Penny Post—April 1992

The April 1992 issue of *The Penny Post* is the sixth issue published by The Carriers and Locals Society, which was founded almost two years ago. Dominating this issue is a several part study of the stamps of the Westtown Boarding School, a stamp which is one of the smallest in the world. Arthur B. Gregg, along with additional commentary by Editor Gordon Stimmell, describes this stamp in detail; its history, its use, its printers, its varieties and its forgeries. It can only be described as first class coverage of the subject.

The considerations given to establishing a value for a document include the type of document, abnormal usage and multiple impressions. Information regarding tax rates and tables of earliest reported usage is also given. Other than written description of the various dies there is little written text, almost everything is presented in tabular form. Only 475 copies were printed. 

Michael Gutman rounds out the issue with a short article about Hale & Co. and Robson Lowe with a mystery covery bearing a 5¢ Paoli Fair stamp with a portrait resembling Queen Victoria.

## Sight and Time Drafts and the Origin of the Restrictive Clauses



A time draft, payable in 30 days after date. The tax due was 25¢, which was paid with a 25¢ stamp ignoring the 2¢ value of the stamped paper.

The subject of this, and several ensuing columns, is the restrictive clauses that became a part of the stamps imprinted on various documents. The earliest use of the term restrictive clause appears to be in Samuel Smith's series of articles in *The American Revenuer* (1970).

It is certain that our earliest revenue stamped paper did not have printed restrictive clauses as part of the stamp designs. American Phototype's early Type A is not known with an additional clause. The early rainbow of Type B colors (black, blue, brown, bronze, green, red, violet and purple) is also unknown with these additional clauses. Of the Type B imprinted stamps, only the color orange (which became the standard) is known with the additional printed clauses. When and why did these clauses come into use?

Before answering this question for the phrases that became part of the American Phototype imprints, one must at least look at Butler and Carpenter's earliest stamped paper. One might be tempted to suggest that the two titles, Bank Check and the general U.S. Internal Revenue (found on RN-I1 and RN-I2 respectively), function similarly to these clauses. It seems reasonable to reject this, since the notion of matching usage for the adhesive revenues had been abandoned several years before stamped paper came into use. Clauses used in conjunction with the imprinted paper of Joseph Carpenter will be the subject of the next column.

The opening paragraph of the April 15, 1867, letter of E. A. Rollins, Commissioner of Internal Revenue, to the manager of the American Phototype Company is very interesting with regard to the clauses. It contains the vital clue to how the clauses came about.

"Instances having been brought to the notice of this office, in which instruments upon which stamps have been imprinted by your Company, have been used for purposes which subjected them to a higher rate of duty than that represented by the printed stamp, it becomes necessary to take such action as will prevent the public from being misled by this course." (Mahler (1988), p. 178)

What imprinted documents do we possess that were understamped? Among the checks, drafts, and receipts, I know of none.

On what kind of documents was there the potential

for underpayment? One of the more obvious examples of an imprinted document that might have been underpaid is a draft that was written as a time draft. As a matter of fact there is a supply of drafts of the Iron Cliffs Mining Company that has additional stamps added to pay the rate for a time draft of the face amount of the draft (see illustration).

This particular example of the Iron Cliffs draft is a time draft, payable 30 days after date. Beginning August 1, 1864, the tax due on a time draft was five cents for every \$100 or fraction. The amount of this draft is \$497.27, and thus the tax is 25 cents, paid by the addition of a 25 cent first issue adhesive stamp and ignoring the two cent imprinted stamp. Only 23 cents would have had to be added.

Every example of the Iron Cliffs time drafts (I have seen at least one that is a sight draft with no additional adhesive stamps) I have seen ignores the imprinted stamp and therefore becomes an example of overpaying the requisite tax on the time draft.

A good number of the clauses that were added to the imprinted revenues are clauses reminding the user that the imprinted revenue is sufficient only for a sight draft or a bank check. These sight draft clauses reminded the user that if the imprinted document was written as a time draft, the imprinted revenue was insufficient to pay the requisite tax.

Given this interpretation of the clauses, how does one look at the small number of cases where a "receipt" clause was imprinted on a bank check or sight draft (the opposite, bank check or sight draft clause imprinted on a receipt, also occurs). They have been referred to as illegal. This just seems to be too strong a statement. They certainly are an imprinting error, but certainly not illegal. No more illegal than using a first issue adhesive with the bank check title on a receipt!

A simple examination of the text of the clauses intended for use on checks and drafts by the American Phototype Company shows little variation. If one ignores whether the text is imbedded in a rectangular tablet, an octagonal tablet, or within the design of the stamp itself, there are only three restrictive clauses. The first, good only for checks and drafts payable at sight, occurs only with the Type B stamp (RN-B16 and RN-B17). This generic clause is split into two separate restrictive clauses for use with the Types C, D, and E. One of the clauses, good only for bank check, is reserved for bank checks; the other, good only for sight drafts, is intended for use on drafts payable on sight.

One might ask why the clauses disappeared. Why don't they exist on Type F, for example? Beginning October 1, 1872, most of the documentary taxes were abolished. Only the two cent tax on bank checks and drafts payable at sight remained after that date. In fact time drafts were no longer taxable. And so, the two cent tax on checks and drafts payable at sight could have been avoided entirely by making the instruments payable at some time in the future. The inconvenience of tracking when these time drafts could be presented for payment and the then current practice of paying what one owed on demand (immediately) probably prevented the wide-spread use of time drafts to avoid the two cent tax. However, there is at least one surviving example that illustrates this point. Kimber Wald (1983) illustrates an Type E facsimile used in November, 1873, when the Type E two cent imprint was still current. Wald indicates this is a fradulent use of the facsimile with intent to evade paying the two cent tax. However, an examination of the draft clearly indicates this is a time draft (payable three days after date) and thus not subject to the two cent tax on drafts payable at sight. Seen in this light, the Type E facsimile is not intended as a deception for the government's eyes. But since the Type E was the current imprinted two cent stamp, it is probably intended to prevent raising the suspicion of the payee that there is no stamp on the draft.

In the next column I will continue to explore the restrictive clauses as practiced in conjunction with instruments imprinted by Butler and Carpenter firm in Philadelphia.

## New \$200 Firearms Transfer Tax Stamp

There is now a new variety of the \$200 Firearms Transfer Tax stamp in use. The enlarged illustration of the new stamp resembles RY2. In fact the design appears to have been photographically drived from RY2. This stamp, however, is not engraved but is printed by photo offset. Thus, the details are much less distinct than on RY2. The color is a somewhat darker shade of dull blue than RY2.

The stamp differs in several other important respects. It will be noted that there is no printed serial number but rather, a blank space for the number to be entered by hand. It is my understanding this proce-

dure was instituted to thwart the possible illegal reuse of the stamps on other Form 4s. Apparently in the past the forms were keyed to the number on the stamp without regard to the particular firearm involved. Now, the form and the stamp are keyed to the serial number of the weapon, which is essentially unique, thereby eliminating the possibility of the stamp being re-used for another weapon. Obviously, if a particular weapon was transferred again another stamp would be issued, probably with the same number inscribed. To the best of my knowledge weapon serial numbers are not restricted as to the number of digits so there should be no particular numerical sequence of the new stamps.

The new stamp is perforated 12.5 on all four sides, so is quite possibly printed in sheet format, without the tabs as before. I have not examined the stamp for a watermark. I am not sure when the Internal Revenue Service or the Bureau of Alcohol and Firearms began using the new stamp although I believe it was within the last year or two.

Obviously this should be given a new number by Scott. Unfortunately, they will probably assign it number RY2c; in reality this should be number RY7. The current RY2a should be RY2, RY3 should remain the same, RY2b should be renumbered RY4, RY4 should be renumbered RY5, RY2 should be RY6 and the new variety then RY7.

It would be assumed that this stamp could be purchased from the IRS in Washington, the same as previous varieties and the \$5 stamp could. It is requested that if any other members have any additional information they contact the editor for publication in these pages.

## The American Revenuer: 1947-1992

The May 1956 issue of The American Revenuer was the largest single issue published up to that date and the first one (and only one until January 1981) to have a cover. This was a special issue produced in extra quantities to distribute at FIPEX, the Fifth International Philatelic Exhibition held in New York City that month. One of the articles in that issue was "The American Revenuer" by then ARA Vice President Morton Joyce. This listing described the physical characteristics of each issue of this journal to date and most importantly, it adjusted the numbering system of the issues.

Early issues of *The American Revenuer* were often numbered in what would be charitably called a strange system. The journal appeared at irregular intervals for the first few years and publication suspended for a year in 1954. Over 350 issues of The American Revenuer have appeared since that listing. Recent years have not been without their numbering anomalies and various supplements have appeared. There has been interest to update this list so that members wishing to complete collections of the journal know what comprises a complete set.

The listing through early 1956 is Joyce's. Not every issue is listed, only those worthy of some note such as those with supplements or misnumbered or misdated issues. This is not an index or list of contents; contents will be listed in subject order in the June 1992 supplement which will also be an index to other revenue articles in serial publications.





### Ogden D. Scoville

Ogden D. Scoville, ARA member 531 and former ARA President, 68, passed away March 23 in Springfield, Missouri. His wife, Alexandra, indicated he died of kidney and heart failure apparently related to diabetes.

Recently Scoville had been working to gain signatures statewide to make the November ballot as the Libertarian candidate for governor of Missouri. He grew up in Long Island, New York. As a young man, Scoville worked as a mining engineer in several Western states. Settling in California, he sold insurance and then ran a securities brokerage firm. He visited Springfield in 1974 and moved there four years later when he retired.

Scoville joined the ARA in 1955. During the 1960s he was a regular at the Los Angeles chapter meetings of the ARA. His primary collecting interests were US taxpaids. He was the author of several articles in *The American Revenuer* about customs stamps. He served as ARA President from 1978 to 1980.
