



President's Letter

I was thrilled to see one of our members take the grand award. How ironic that a revenue exhibit should take home the grand award at the *POSTAGE STAMP MEGA-EVENT* in New York! Mike Mahler, a frequent contributor to *The American Revenuer*, took the grand award with "United States Civil War Fiscal History: A Survey of the Documentary Uses." After the announcement, I noticed lots of people examining the exhibit. That's great publicity for our area of philately. At the same show David Torre was awarded a vermeil for his "Classic State and Local Fish and Game Stamps" and James Benedict received a silver for his "Pre-printing Paper Folds on Revenue Issues." A great showing for revenues in New York. All three exhibits showed a lot of interesting material that is not frequently seen. David Torre also received the reserve grand at *PHILATELIC FIESTA*. There have not been a lot of revenue exhibits that have taken grand awards or reserve grands other than at shows where the ARA has participated. Kudos to all of our members who are exhibiting.

I also made presentations on "What is a revenue stamp?" during the *MEGA-EVENT*. You may recall that I wrote briefly on this subject several months ago. It is true that the current FIP definition is somewhat restrictive. However, there is much material that is in the marketplace that we have collected along with our revenues, that was even a part of protecting the integrity of collecting fees and taxes. I'm

thinking of things like the tax-free potato stamps, bottled in bond for export (without payment of tax) stamps, lock seals, and hydrometer labels. Don't they deserve to be collected and exhibited?

The dispersal of the enormous collections and accumulations of the late Morton Dean Joyce have had an enormous impact on the

development of many of the current exhibits and on many of our collections. Joyce's collections covered every area of U.S. revenues. Even in the less travelled areas like state revenues, lock seals, taxpays, and U.S. possessions, Joyce collected seriously and extensively. We are now seeing material that many of us didn't even know existed. For example, both the grand award and reserve grand award exhibits mentioned above contain material from the Joyce collections.

Another area of activity to which I have referred in one of my past letters, is the status of revenues in international (FIP-sponsored) shows. Although I have exhibited twice internationally, both *FINLANDIA* and *INDIA* had only experimental classes for revenues. I was pleased with the silver and large silver which

The Continuing Enigma of Fernet-Branca

A recently acquired standard size (5 1/8 x 3 1/8 inch) Branca Brothers trade card has brought up some very interesting questions. Acquired on a recent trip to a large eastern flea market, the card will be added to my Match and Medicine collateral collection.

The gold bordered multi-colored chrome-lithographed card is in excellent condition and dates from approximately 1895 to possibly as late as 1905. The card does not bear any indication of the size or cost of the product.

Henry Holcombe's *Patent Medicine Tax*

Stamps was sought out for additional information on the Fernet-Branca Company. He explains that trade marks were registered in 1893 by Maria Branca Scala of Milan, Italy. He further explains that the manufacture of the bitters and its worldwide distribution were exclusive to the company's Milan headquarters. Who the U.S. importer was has never been established.

In his story several additional points are made: the firm's tax stamp (Scott RS279) at 4¢ is the only one of its denomination in the 1898 private die series. There was no specific tax rate vs. retail selling price combination that would require a four cent stamp. The actual selling price has never fully established but was believed to have been \$1.60 per bottle. This would have adhered to the 1/8¢ tax per 5¢ retail product schedule used for lower priced items.

The ordered stamps were sent to the firm's headquarters in Milano, Italy, to be affixed to the bitters, but we do not know by whom the stamps were sent, or the finished products were returned to the U.S. for distribution.

Holcombe's article suggests a tightly owned firm, but did that include making trade cards for only authorized distributors by specific city?

While comparing the front of the card with Holcombe's written description of the RS279 design, an interesting deviation was revealed in the form of an imprint: "STAB. D. COEN. C MILANO" on its lower right hand corner border. This strongly suggests that not only the bitters but the advertising trade cards as well were made in Italy. As can be seen it is bi-lingual on the reverse, and lacks the explicit patent testimonial of many of its U.S. brethren and it bears the imprints of two Chicago, Illinois, firms: Messrs. Grommes e Ullich, 104-106 Madison Street and Messrs. L. Gandolfi e Co., 1443 State Street.

Not unusual you say, but these imprints are not handstamped or press printed at a later time. They appear to have been done at the same approximate time as the front of the card. There is no unusual difference in the type or

value of the black ink used to do the rear of the card other than a difference in density and imprint appearances caused by the type style and size used. Nor is there any misregistration as might be expected if the imprint had been done later, into an open area left for that purpose.

Most U.S. trade cards of the period were handstamped or imprinted locally by the retail merchant in an area specifically left for them, but were supplied of course, by the product manufacturers.

Was one of these firms the importer for the U.S.? Was a front only sent out, with the entire back blank, to be locally done? This raises the question of how many cities or places were these cards made for?

Was an imported spirits or similar tax required in addition to the patent medicine rate (i.e., did the government possibly consider Fernet-Branca in the same light as the earlier domestic medicines "Sunsmile" of Cook and Bernheimer or Lawrence and Martins' "Tolu Rock and Rye"?) Holcombe speculates on a "Special Arrangement" with the Commissioner of Internal Revenue but could not pin anything down.





The **Tennessee Ammunition** stamp illustrated here was submitted by member E. E. Fricks. They are on a slightly glossy self-adhesive paper, apparently die cut as the corners are slightly rounded. These small 17.5 x 11 mm stamps appear to be in some small

self-stick label format. The red 5¢ was used on a box of 25 containing rounds and the green 10¢ on a box containing 100 rounds. Can anyone add any additional information that can be reported in *The American Revenuer*.



The Revenue Journal of Great Britain—March 1993

M&M Fakes

As a one-time collector of German States stamps, I am well aware of the scourge of fakes and forgeries which the collector of Germania must contend with. The well-regarded *Germany Philatelic Society Reference Manual of Forgeries* has expanded to ten volumes, and it is still growing. The prevalence of these album weeds was partially responsible for my decision to discontinue this collecting interest.

So when I considered collecting U.S. private die proprietary revenues a few years ago, an appealing aspect of this collecting area was the pronounced lack of fakes and forgeries. However, probably no field of philately escapes the seeds sown by the forger, and there are indeed some issues in the match and medicine area which have the potential to attract the unscrupulous.




Figure 1. A William Gates' Sons private die stamp with fake roulettes.

Figure 1 illustrates perhaps the most common example. Those few stamps issued some-

times with roulettes, sometimes with perforations, demand caution of the collector. The temptation exists among the dishonest to remove the perforations from a large-margined copy of, say, the William Gates' Sons one cent issue, and fake some roulette teeth to create a higher valued item.

I acquired this item at a recent mail auction, and promptly submitted it to a philatelic certification service. Yup, the roulettes are faked. The auctioneer, in his note included with my refund, allowed that it "didn't look right" to him either. So my suggestion to fellow M&M collectors is to have all of your high dollar rouletted stamps checked.

Similar problems lie with the few issues which were provided both perforated and imperforated. Suspect any stamp in this category where the price differential is great. Perforations can be trimmed to create an instant imperforate; contrarily, an imperforate stamp can have fake perforations added.

Figure 2 illustrates the enigmatic perfo-

rated Brandreth, Scott RS35p, listed but unpriced. Little is known about this issue, how it came to be, or even how many there are. No census apparently included this anomaly. I won this lot at a recent auction; accompanying it was the original attest from Edward Stern of New York's Economist Stamp Company. Stern sold this item to Morton Dean Joyce in 1950, and supplied his attest that he considered the stamp to be genuinely perforated. He even signed the back of the stamp.

But the certification service was not impressed. It opined that the perforations were faked. The auctioneer felt so strongly that the stamp was genuine, in turn submitted it to another certification service. This time the finding was "genuine in all respects." This difference of opinion, though quite unusual, does serve to remind us that the opinions which the services provide are just that. (Only the Germany Philatelic Society Expertization Committee guarantees its findings.)

Other traps await. Exercise caution with ultramarine issues. It seems that some dealers and collectors are only too glad to label any light or pale blue issue "ultramarine." I recently sent four supposed ultramarines to be authenticated. Two were judged to be true ultramarines. The others represented wishful thinking on the part of the previous owner.

We should be wary also of those stamps

printed on papers of differing colors. The wrappers in orange, yellow and red-orange really ought to be looked at by a trusty team of experts. The incentive is there for the faker to dye an inexpensive item to make it appear to be a more costly relative. The same goes for pink papers. Any Powell wrapper, too, should be

submitted to sort out the buff and white papers.

In conclusion, any high dollar item should be examined by the experts. The fees are relatively minimal, and they truly serve as an investment in peace of mind.

Zimbabwe are described by Andrew Hall and the first part of a series by Robson Lowe tells the revenue side of the business of Bradbury, Wilkinson and Co., the British security printer. In the article Lowe describes many of the revenue items that were in the archives of this firm. The editor Clive Akerman also includes another part of this series on the revenue stamped paper of Argentina.

Included with this issue was a booklet *The World of Revenue Stamps* which was the catalog to an introductory exhibit of revenue stamps of the world that was shown February 18 at the Royal Philatelic Society in London. This was a 52 frame exhibit of worldwide revenues from the collections of a number of members of the Revenue Society shown at one of the best

attended meetings of the Royal in recent years. In the entrance hall, those attending were greeted by "a little round embossed GB revenue stamp denominated ONE MILLION POUNDS (and overprinted SPECIMEN)." In contrast to this the exhibit catalog has a 5p embossed stamp, currently the lowest value in use, with the date plugs "18 / 2 / 93" the date of the exhibition.

The Revenue Journal of Great Britain is published quarterly by the Revenue Society of Great Britain. Membership includes a subscription to the journal and costs \$36 per year. The society's advertisement appears in this issue of *The American Revenuer* and gives contact addresses and instructions for payment of dues.
