

The Man of Steel pitches savings stamps for Uncle Sam

Collectors with a sweet tooth for savings stamps and related memorabilia may find the following item appetizing, although it is arguably a bit odd, offbeat and unusual. I say odd, offbeat and unusual, because it is on video, and if that does not qualify as an odd, offbeat and unusual item to add to one's collection, then nothing does.

The item in question is a "lost episode" from the old *Superman* TV series with George Reeves. As for why the episode is lost, it seems that for some reason or other it was never aired at the time it was made, which is to say, in 1954.

The episode is entitled "Stamp Day For Superman," and for collectors with a taste for savings stamps it provides a savory, nostalgic look at the U.S. savings stamp program of the early 1950s, with Superman promoting the virtues of savings in general and of "Treasury savings stamps" in particular.

An advisory statement at the end of the episode reveals that, "This motion picture was donated to the United States Treasury Department as a public service by Superman, Inc."

What more can one ask for? Not only does the episode have entertainment value as such, it has historical value as well. In point of fact, what it is essentially is an honest-togoodness, semi-official government TV show from nearly half a century ago featuring America's all-time favorite superhero in the role of a pitchman for United States savings stamps.

Together with the pilot episode of a projected *Superboy* series from 1961 which apparently never took wing, "Stamp Day For Superman" is marketed by Video Dimensions under the general title of 'Superman: The Lost Episodes. Both episodes are black and white, and the tape runs about 50 minutes total.

"Stamp Day For Superman" features a plot with two intermeshing elements. The first element revolves around Clark Kent's plan to do a feature story on the weekly Stamp Day drive at Jimmy Olsen's grade school alma mater.

Threatening to disrupt this plan is the second element of the plot line—namely, Lois Lane's abduction by a petty crook who wants to waste her for fear that she might be able to finger him in a jewel heist.

Not to worry. It is Superman to the rescue—just in the nick of time, of course. And afterwards, still running (flying?) on a supertight schedule, our superhero manages to squeeze in a guest appearance at the grade school Stamp Day drive.

In his pep talk to the school kids (and to the expected TV audience as well) the Man of Steel holds class on the virtues of buying U.S. savings stamps each and every week.

He concludes his patriotic sales pitch with the following words of encouragement and advice: "And so, boys and girls, be super citizens and have a super future by saving regularly with United States savings stamps at school."

The episode ends off with Clark Kent walking into his office with a "U.S. School Savings Program" stamp album for himself, Lois Lane and Jimmy Olsen. Oh yes, he also has a fourth, extra album, one made out to "Superman." Fade to black. End of episode.

All in all, I have to admit that I found "Stamp Day For Superman" quite interesting from a collector's point of view. Odd, offbeat and unusual it may be, but it fits in rather nicely with the various other collateral items related to savings stamps.

Cal-Rev April meeting

April 10, 2003, was a great Saturday to hold a Cal-Rev meeting at the Easter Seal Facilities in Sacramento. There were 18 members in attendance waiting to talk and show revenue treasurers.

John Wetterling (Author of a ten-volume Chinese revenue catalog) was first to speak he mentioned his radio program about antiques, carried on some 16 stations. He commented about the size of some antique shows and a need for a map or GPS to find your way about.

Ralph Walther told his grandson about duck stamps. His grandson asked, "Why do they exist?" Ralph's answer was "Because the program works." He went on to explain how duck hunting was uncontrolled in the 1930s and devastating to the migrating flocks. He explained about the program, instituted in 1934, to provide funds for establishment of bird sanctuaries and regulate hunting in order to preserve wild ducks for future generations. Ralph mentioned that a hunter was only allowed to buy a single stamp in 1934 and place it on a license which explains the scarcity of multiples of RW1. It was not until 15 days before the expiration of these stamps that the law was changed allowing multiples to be purchased. Ralph then showed a magnificent MNH large multiple of RW1 which included the upper plate block. He also showed a MNH multiple of RW2 also with upper plate number.

Betty Walther brought on the beer, that is a block of four of the 1947 500 barrel beer stamps, punched, she said a hunks and chunks variety and another un-punched example.

Ed Jarvis is continuing the search for Lux-

embourg revenues. Bill Barr brought a set of the 1874 Mexican Contribution Federal revenue proofs, and a large multiple of the 5 pesos from this issue. "Chaz" Nelson showed us various printers' efforts in printing Indian Princely States revenues from exquisitely engraved revenues to mundane rubber handstamps.

George Condas talked about the winged Greek Victory documentary stamp. He covered the various values, colors and the its many revenue uses. It was the revenue stamp workhorse because it is the most surcharged/used revenue of the 1912–1922 period. He mentioned that the green Victory 1 drachma with red value is the scarcest.

Al Williams, not yet a member, was introduced as the new printer of the Cal-Rev's first color newsletter. All present approved of this major improvement. Dave Beeby, a long time member, talked about his interest in AMG revenues.

Jerry Lurie talked about COALPEX and the possibility of having a luncheon before our meeting there on June 5. Our ARA representative Don Green talked about his rare medicine revenue and that there was no consensus on its being genuine. Bruce Brunell talked about Argentina and Anson Stout talked about local Indian States revenues, Cow Welfare or Holy Cow stamps.

Our editor Rick Graham announced that he was going back to Stamp Camp again this summer to attend Ron Lesher's symposium on Advanced Revenue Collecting. Hope to see you at our next meeting at WESTPEX Sunday, April 27th at 1:00 p.m.

The Penny Post—January and April 2003

The Penny Post, published by the Carriers and Locals Society, contains studies of the classical era U.S. private and express company posts and the early U.S. carriers services. While articles about a number of posts appear in each issue, several are of special note, maybe as being more unusual.

The January 2003 issue contains "S. Allen Taylor's 'Forms' Known Colors and Subjects" by John Bowman, Gordon Stimmell and Larry Lyons. This well known faker would print various groupings of his bogus stamps at one time using a variety of different colors of ink and paper. Twenty-seven of these different forms are identified with a chart showing the different colors and a chart showing the subjects and what form in which they appeared.

Ron Lesher to conduct course at APS Summer Seminar

Master new philatelic skills, make new friends, and explore the fascinating world of **Advanced Revenues**—one of five featured courses at this year's APS Summer Seminar on Philately. The weeklong seminar meets Sunday, June 22, through Friday, June 27, at the Atherton Hotel in State College, Pennsylvania.

Back by popular demand, Ron Lesher returns with a program that will help you learn how to identify all U.S. revenue stamps, locate and use sources to understand the background of those stamps, and identify forgeries of first issue revenues, the early proprietary stamps, the match and medicine stamps, and the early narcotic tax stamp provisionals.

Students will select an area of interest and complete a project, such as identifying their stamps, locating tax rate information, producing a brief write-up, and mounting their stamps with the information. Others may choose to develop a protocol for identifying forgeries in their special area.

Major courses meet Monday through Thursday for two hours in the morning and one and one-half hours in the afternoon. In addition to attending Ron's course, students may also join in the morning general sessions and afternoon electives, to learn about other philatelic topics. These sessions may be workshops in specific topics or roundtable discussions involving both instructors and students.

During the week, students also have ac-



cess to the services of the APS Building and the American Philatelic Research Library. Many students visit to search for collectibles among the Society's sales circuits; to research their interests in the library's holdings, or tap into the resources of the APS Reference Library. Other highlights of the seminar include dinners, an auction of student material, a buy-sell-and-trade night, and field trips.

Seminar tuition (\$450 for APS members; \$550 for others) includes a reception and dinner on Sunday, dinner on Monday and Thursday evenings, and morning and afternoon break service. Travel, meal and hotel accommodations are not covered.



In 1987-88, Donald Duston published his compendium of revenue stamps issued by former French colonies and the succeeding independent states of sub-Sahara Africa (Duston, 1987). Recognizing the need not only to incorporate new information about older issues but also to catalogue newer issues, Don was preparing a second edition at the time of his passing in 2000.* He had kindly shared a draft of his Cameroun section (1997). Rather than languishing unpublished and therefore unavailable to fellow collectors, we have extended Don's revised draft, incorporating additional information acquired more recently. This report focuses on revenue stamps of Cameroun issued since 1964, specifically since the introduction of stamps with the emblem of Cameroun. Other updates are contemplated for issues prior to 1964, which have the emblem of France.

In preparing this report, one of us (MW) was fortunate to have acquired a large lot of specimen revenue stamps for Cameroun, offered by the Spink auction house, London,

U.K., in 2000. The stamps were from the De La Rue archives. The lot consisted of more than 60 sheets or part sheets of 30 different stamps for 4 different revenue purposes. None of the stamps were listed in Duston's catalogue but Don had recorded one in his draft update as having been issued.


In his catalogue, Duston had reported that Cameroun revenue stamps (other than the emergency wartime issues (Bratzel, 1996)) issued since the late 1930s were on paper watermarked AT (Atelier du Timbre) plus two digits indicating the date that the paper was manufactured. In his update, he noted the watermark AGT (Atelier Générale du Timbre). In examining available stamps issued since 1964, we record five different watermarks—AT64, AT65, AT66, AGT, and

squares alternately bisected horizontally and vertically with multiple watermarks used for some issues.

The first four watermarks were used by the French government, the last by De La Rue. The change in watermark denoted a shift in the 1980s from Paris to the private sector for the preparation of Cameroun's revenue stamps. The bisected squares watermark was sometimes used by De La Rue for postage stamps. The change in printers also reflected a shift in printing technology, to a combination of recess and lithographic printing.

We describe and illustrate below Cameroun revenue stamps issued since 1964. An "X" denotes the existence of a particular stamp with a particular watermark. All denominations are CFA francs. The colors are given, respectively, for the frame / emblem, the background and the function / denomination. The function and the denomination were applied with one or two printing plates. We also observe different color shades for some stamps as well as

slightly different lengths for some of the words applied with the duty plate (e.g. timbre fiscal). This may or may not infer multiple printings or press runs. Further, we observe damage to some of the letters comprising the duty plate from which, in theory, it would be possible to plate the position of the stamp in a full sheet. The authors would appreciate information to further update what we present here, especially the opportunity to examine additional stamps.



The examination of multiple sheets of specimen stamps provides further insight into this issue. Each pane has 100 stamps, arranged 10 x 10, with a black imprint "THOMAS DE LA RUE AND COM-PANY LIMITED. MARCH 1987" in the bottom margin below stamps 98 - 100. The two-line punched "T.D.L.R. / SPECIMEN" was irregularly applied and generally covers six stamps, with the occasional stamp unpunched. Full sheets of the 100 and 10,000 franc specimen stamps have three green control letters printed on each stamp and a corresponding dummy number "B 000000" in the top margin above stamp 10.

The existence of two different perforation

gauges—14 $\frac{1}{4}$ and 14 x 14 $\frac{1}{4}$ —indicates the use of two different machines to perforate the stamps. The perforation 14 $\frac{1}{4}$ stamps have 26 holes horizontally, and the perforation 14 x 14 $\frac{1}{4}$ stamps 25 holes.

The stamps are comb perforated, from either left to right or right to left, across the sheet. When perforated from left to right, the left sheet margin is not perforated and the right is. Also, there is a large "perforation" on the right side of each stamp. The "perforation" is actually a gap that results when the head of the comb perforator repositions itself across the sheet. The 100 franc stamp, position 1 in a sheet perforated from the left, shows the unperforated left sheet margin and the large "perforations" on the right side of the stamp.



When the sheet is perforated from right to left, the right sheet margin is not perforated, the left is, and the large "perforation" is found on the left side of the stamp. Whether perforated from left or right, the top and bottom margins are not perforated.

On one of the 100 franc sheets, there are three cross hairs at each of the two top corners, one for each color — blue, light blue, and black — but, at

the two bottom corners, there are only single cross hairs in blue. On the 1500 franc sheet, the three cross hairs are at the two bottom corners and the single cross hairs at the top. For other sheets, the cross hairs may be as noted above, or only at the top two corners, or the bottom two, or the left two.

The cross hairs serve two purposes—to confirm color registration and to serve as a benchmark for the perforator head. When the colors are perfectly aligned, the cross hairs are superimposed. When the perforator head is properly positioned, the corner perforation hole is centered on the cross hairs. The cross hairs are shown in the enlargement.



Each sheet has three very small blue circles in the margins although, in some cases, the circles have been partially removed when the sheets were guillotined to size. For example, on the 100 franc sheet, the circles are in the top margin above the vertical perforations between the stamps at positions 5 and 6, in the left margin to the left of position 71, and in the right margin to the right of position 80; there is no circle in the bottom margin. On the 1500 franc sheet, the circles are in the bottom margin below the vertical perforations between



positions 95 and 96, to the left of position 21, and to the right of position 30; there is no circle in the top margin. For the 100 franc stamp, we have a sheet with each array of circles. On all of the 27 sheets (or part sheets) examined for all 22 denominations, only the circles in the top and bottom margins are pierced.

The circles serve two purposes — small pins in the bed of the perforating machine pierce the circle and hold the sheet in place, so that the perforator head falls accurately in the stamp margins. The circles also serve as guides for guillotining the stamps into panes of 100.

The differences regarding the cross hairs and the small colored circles lead to the question as to the size of the printing plate. If would appear that the plate consisted of two vertical panes of 100 stamps and perhaps more than one pair of panes laterally, depending on the size of the drum on the rotary printing press.





The pane has a single, dark red cross hair in the lower left corner. In addition, a dark red vertical line extends from the sheet margin almost to the cross hair. The line is superimposed on a shorter, broader pink line. Below stamp 93 is a small, pierced red circle, as well as three horizontal red bars with a vertical crossbar connecting their right ends. There is a mirror image of these markings below stamp 98; the hole is, however, unpierced.


Each pane has 100 stamps, arranged 10 x 10, with a black imprint "DE LA RUE" in the bottom margin below stamp 100. A dummy sheet number "00000" is printed in black above stamp 10. The two-line punched "T.D.L.R. / SPECIMEN" was irregularly applied and generally covers six stamps, with the occasional stamp unpunched.

There are five colored cross hairs in each of the four corners of the sheet—magenta, cyan, yellow, dark green, and black; these closely correspond to the corner perforation hole of the respective stamp. Three vertical lines—magenta, cyan, and yellow extend from either the lower right or upper right corner grouping of cross hairs to the sheet margin.

Dark green circles are found in two arrays. The first array has a pierced circle in the top margin, centered above the perforations between stamps 5 and 6, and unpierced circles to the left of stamp 71 and to the right of stamp 80. In the second array, the pierced circle is in the bottom margin, centered below the perforations between stamps 95 and 96, and unpierced circles to the left of stamp 21 and to the right of stamp 30. As for the 1987 timbre fiscal stamps, for the 200 and 500 franc denominations of the rtv stamps, we have partial sheets with each array of circles.

International travel from Haiti in the 1980s and the Carte de Citoyennité

On April 8, 1983, President Jean-Claude "Baby Doc" Duvalier (1971–1986) decreed the creation of the *Carte de Citoyennité*, yet another unique tax stamp in the annals of Haitian tax history. This law was meant to be a two-part one, whereby anyone intending to travel abroad would avail himself first of a citizenship card. This was for all inetents and purposes an identity card that was designed to be carried in a wallet or purse. With this in hand, he/she would report to the Bureau des Contributions to purchase a decallike card for his passport, also called *Carte de Citoyennité*.

By contrast, earlier in the 19th century, one merely took photos and appropriate identification to a Justice of the Peace, who, having established the identity of the person would then write a statement on revenue paper declaring that the bearer of the document was who he/she said and was born in Haiti, etc. This was then taken to the appropriate Ministry where a passport was issued.

While *Le Moniteur*, Haiti's official government weekly gazette, reported on changes in laws regarding identity cards in issues of 1937, 1940, 1971, 1978, 1981, etc., to this writer's knowledge, it never did so on a law decreeing the creation of a citizenship card. This two-step *Carte de Citoyennité* appears to have been unique to Jean-Claude's genius.

These were the items needed to obtain a citizenship card. One had to show: 1. Birth Certificate; 2. Identity Card; 3. four black and whites and two color photos of type used for Citizenship cards; 4. Marriage Certificate, if a married woman; 5. Death Certificate of husband, if widow; 6. Proper parental permission to travel for a minor; and 7. Naturalization papers for naturalized citizen, etc.



These cards were valid for five years. In Figure 1 we see two laminated examples. The photo side shows the daughter of a Haitian friend. The elaborate back is of a card issued to her mother. The amount paid for this type card has not been determined.

Once the Carte de Citoyennité was in hand, the applicant could purchase the decallike card that would be affixed in the new passport. This Carte de Citoyennité cost 50 gourdes (\$10.00).

Shown as Figure 2 is the short-lived *Carte de Citoyennité* designed for passports. It measures 68 x 51mm and its colors are light

sored by The American Revenue Association. 1987-88. Cameroun provided in personal communications dated October 14 and November 6, 1997.

orange and blue. Barely perceptible to the naked eye is the modern statue of the Unknown Maroon (located in Port-au-Prince).

Lest the reader think for a moment that the traveler's expenditures ended at this point, there was the matter of the costs for the passport itself. Haiti issued a 32-page passport valid for 1, 2 or 5 years and which could be renewed accordingly, as per Table I.

Yet another cost to be factored in when leaving the country was the *Visa de Sortie* or Exit Visa (also valid for re-entry) that cost 35 gourdes or \$7.00 U.S.

To put the matter in something of an economic perspective, an "adult" U.S. passport in 2002 costs \$55.00 and is valid for 10 years. Our citizens do not need an exit visa, al-

though an entry visa may be required for certain countries (e.g., Eritrea, Ethiopia, Uzbekistan, Egypt etc.). If one were a Haitian traveler in 1983 and were to purchase a citizenship card (50 gourdes), plus a five-year Haitian passport (245 gourdes), and then one Visa de Sortie (35 gourdes), the amount would have been 330 gourdes (divided by 5) or \$64.00; and this is not allowing for the unknown cost of the identity-like card. Within a purely Haitian context, when we read that Haiti is and was the poorest country in this Hemisphere, with less than an average yearly income of \$200.00, the costs for the paperwork entailed in international travel at the time was prohibitive for most. And this does not even take into consideration the actual cost of transportation!

While this writer has found nothing specific regarding a date certain for the discontinuation of the sale of the *Carte de Citoyennité*, suffice it to say that it very likely occurred shortly after President Duvalier's ouster in 1986.

Canadian Revenue Newsletter—December 2002 and March 2003

The latest two issues of the *Canadian Rev*enue Newsletter feature parts two ("Manufactured Tobacco Stamps and Stamping: 1880-1883") and three ^a"Manufactured Tobacco Stamps and Stamping: 1883-1897") of Christopher Ryan's series "Canada's Stamp Taxation of Tobacco Products: 1864-1974." Well illustrated and thoroughly documented, this series is to be continued and will probably become the definitive work on the subject for some years to come.

The December issue also contains "Corner Folds on Canadian Revenue Stamps" by Leopold Beaudet which covers these freaks primarily on the first three Bill Issues. Nineteen are illustrated and the author traces many of them through various sales and collections.

The March issue also presents "Fifty-cent Admiral Blocks Paying the Federal Excise Tax on a Stock Transfer" by Christopher Ryan. The illustrated item shows the use of postage stamps to pay the excise tax which was permitted from July 1, 1920, through September 30, 1923, after which excise stamps were required.

Revenue Journal of Great Britain—December 2002 and March 2003

"GB Medicine Tax Stamps-some background" highlights the December 2002 issue of The Revenue Journal of Great Britain. R. H. Champion wrote this article several years ago as a chapter in a projected book by the late John Chandler covering the medicine stamps of Great Britain; the book was never completed. The development patent or quack medicines in Britain was quite similar to their development in the U.S. A complete lack of regulation allowed often self-proclaimed doctors to use any ingredients and make any claims without regard to patient safety or to the medicine's effectiveness. In Britain these medicines were taxed form 1783 until 1941 and like in the U.S. those prescribed by a doctor or an apothecary were not taxed. Many of the various types of stamps and some paper collaterial are illustrated. Anyone who is interested in the U.S. proprietary stamps will find this article most interesting.

This issue also presents Joe Ross's "Qatar-work in progress" catalog of that country's revenues. Additionally Giles du Boulay illustrates usage of "Danzig-Police Administration Fee Stamps" and Peter Mansfield presents some information about the "New Zealand 'Theed'" stamps which



were closely copied from those in use in Great Britain.

For a short time during World War II, Thailand occupied a portion of Burma lying north of Thailand. A set of Thai revenue stamps were issued for that area. Alan Cameron in the March 2003 issue relates the story of the "Thai Occupation of Chieng Tung, Burma in World War II and the Thai Revenue Stamps Used There.{ Dopcuments relative to the occupation of this area are quoted and the stamps and usage are discussed and illustrated.

Oscar van der Vliet relates "Netherlands—a ride of taxes" telling of fee stamps that are required to be placed on requests to take a driver's licence exam. Most of that country's citizens are familiar with these stamps.

Peter Mansfield takes a long look at the "GB—Decimal Dark Ages—the QEII Key Types 1971-1983." Key type stamps are those stamps that all share a common background, either in a common color or in different colors. The denomination, the intended use and sometimes even the issuing entity, are then applied in a separate printing. The whole purpose is to cut printing costs. By the time the United Kingdom switched to decimal cur-



rency in 1971, the use of revenue stamps was declining. By 1985 their use was made redundant tlthough use continued in Northern Ireland courts; the author is unable to determine for how much longer, now no one remembers. A new book on Danish revenue paper and its history

Claus Rafner has been named as the author of the third in a series of five books on Danish Tax History being published by the Danish Association of Tax and Customs History (Told- og Skattehistorisk Selskab). The association celebrated its 25th anniversary in 2002, and is publishing the five books on that occasion.

This third volume, which will have its publication date in the autumn of 2004, will have the title of *Enevælde og skattefinansieret stat 1660–1818* (The absolute monarchy and its financing with taxes 1660–1818).

Claus Rafner, who received the degree of cand. mag. at the University of Copenhagen, did his research there into the Danish tax system of the 1600s and 1700s. That degree is the equivalent of the American Master of Arts degree.

There will be about six chapters in this book which stresses tax history, but included will be an illustrated description of the stamped revenue paper issued in Denmark during those years. The first stamped paper series, from 1657, was overlooked in the Poulsen Catalog of Scandinavian Revenue Stamps, Volume II, Denmark, which I edited for publication. These earliest stamped papers have not been described in print before, to my knowledge; certainly not for the philatelist. Claus, whose award winning philatelic handbook and catalog on the Danish taxpaid stamps for alcohol and tobacco, published in 1998, is a good choice by the association to do this new book, and revenue philatelists as well as historians should be pleased with the result.

The illustration here is of a receipt from 1658 having a stamp of the first series. The stamp, which is actually a wax seal with a white paper wafer on it, is impressed in the left upper corner of the document. Below is stated the name of the accountant of the

royal treasury keeping the accounts of the "sealed paper." His name, Thomas Thomison, is either found hand written or, in this case, printed with a kind of rubber stamp. The figure of the seal, which is difficult to see from a photo, is made up of the Danish national coat of arms, that is, three lions on a shield, and below is the year of 1657, referring to the year this duty was introduced. Sealed paper was replaced by stamped paper in 1660, when the next series was introduced.

The first volume was published in October 2002, and the second will be available in late 2003. According to Claus, however, the first two and last two books of the five will have little of interest from a revenue philately point of view.

Each book will be available for DKK 428 plus shipping, and can be ordered now from the Told- og Skattehistorisk Selskab, Østbanegade 123, DK 2100 København Ø, Denmark. Full information, in the Danish language, about all of these five books is available from <www.zise.dk>.

Most important, however, was that both Boker and Weill were very supportive of philately behind the scenes, not wanting any credit for

their contributions. Both will be missed.

Three ARA certificates were awarded at the Edmonton (Canada) National 2003 held March 28–30. The Law Stamps of British Columbia by Ian McTaggart-Cowan was the Best Revenue Exhibit as well as receiving a gold and the Grand Award. Certificates and ribbons also went to The Law Stamps of the Yukon by Ian McTaggart-Cowan along with a gold and to Canada "C" Series Tobacco Stamps by Earle Covert along with a vermeil. ARA certificates and ribbons are avialble to requesting shows from our Awards Chairman, Edward Tricomi (address in the masthead at the beginning of each issue).

The January 1953 issue of *The American Revenuer* announced that "Deats made Honorary Member." They refer to the farmer from Fleming, New Jersey, and author of the "Boston Revenue Book" Hiram E. Deats. Deats became the American Revenue Association's first honorary life member by unanimous decision of the Board of Directors.

A contest to design an ARA insignia was also announced. The purpose was to create a design symbolizing the American Revenue Association, its ideals and purposes. The president, Irv Silverman believed that such a symbol or coat of arms would be almost an essential in an organization of this kind. In what was described as an "elclusive" inter-

view he stated, "It is felt that the dynamic and the intellectual which epitomize the characterization of the motivating force of this organization can best be driven home in the philatelic field through the julicious use of some heroic crest of suitable design and appropriate configuration readily capable of being comprehended by the collector and the general public for that which it purports to portray. In this manner can we take our rightful position alongside the elder and the larger, by announcing the pinnacle toward which we strive. In orther words, we need an insignia which is simple and understandable by all." The Editor noted that Mr. Silverman whished to add the phrase, "But on the other hand, I may be wrong," until he was re-50 years/ 76



Chappel, Bill Larsen and Keith Forfar) would pick a winner which would be submitted to the membership for approval. Entries were to be submitted by March 31, 1953. In the Sprint 1954 issue it was announced that a design by Nelson J. Lauth of Buffalo had been chosen but it wuld be a while before cuts would be made.

The February-March 1953 issue broke the news to the society that one of their priminent members had been killed in an auto accident near Bakersfield, California. Mr. E. R. Vanderhoof began dealing in revenue stamps in 19055 and went into it fulltime in 1930. He had also been an active USA.






